

## YOUR INSURANCE

Just received your new bicycle ? Can't wait to (re)discover the joys of soft mobility?  
To ensure you can bike with peace of mind, your bicycle is covered against theft and material damage.

### YOUR COMPREHENSIVE BICYCLE COVER (OMNIUM)

Your bicycle is insured against theft, attempted theft, material damage and vandalism worldwide through the Pvélo insurance of Aedes.

In the event of an accident, an excess equal to 10% of the value of the bicycle with a maximum of €50 including VAT will be applied.

However, please be aware that if the accident is the result of inappropriate use (alcohol intoxication, fraudulent intent, remunerated competition, etc.), you will be responsible for repair or replacement costs.

In order to benefit from this cover, a few precautionary measures are required:

You must use the lock provided (if applicable) whenever you park the bicycle. The insured bicycle must be secured to an immovable object. If you are using your own lock, you must provide the receipt for this lock. The lock you use must be an Abus Granit + 470 / Abus Granit X Plus 540 or Abus Bordo Granit X Plus 6500 type of lock or any lock with a minimum value of €70 VAT excl.

The only exception of non-use of the lock (provided or personal), is when the bicycle is stored in a private room/space, entirely closed, covered and locked.

Please refer to your Bike Policy to check whether Civil Liability, Individual Cyclist Insurance (bodily injury) and legal protection are covered by your contract.
